1. Adoption of the legitimacy of the meeting

The dates for the call for conference are found to be in accordance with both the district bylaws and the Zonta International bylaws for Call to Conference. This is considered as approved.

2. Adoption of the agenda

3. Election of secretaries, timekeepers and tellers

D-13 Secretary use to be one of the note takers, but D-13 Treasurer Ellen Skartvedt, ZC Egersund takes on the role, as Secretary Berit Birkelund, ZC Næstved unfortunately is prevented from attending the meeting.

Hilde Heggelund from Oslo ZC is elected unanimously as the other note taker.



As the meeting is held by Teams the D13 Board deems it appropriate that Governor Jane Bordal is the chair of the meeting and timekeeper as well. This is considered as approved.

There was no need for tellers in the meeting as all voting were done in advance of the meeting.

4. Roll call of clubs/delegates

Treasurer Ellen Skartvedt calls on all notified delegates and concludes that there is a total of 39 club delegates present + 6 delegates from the D-13 Board, giving a total of 45 district votes.

7. Election of new D13 board

Chair Aase V. Schmidt, Nomination Committee

Slate of candidates for the Board was presented as announced in the Call for Conference.

There are only identified one candidate for election to each office.

A voting member nominating a candidate "from the floor" for an elected position should do so in writing to the Nomination Committee by August 20, 2021.

There were no candidates running "from the floor".

Chair Aase V. Schmidt presents the Election results.

There has been given a total of 39 votes.



The candidates for the District Board 2022-2024 were elected with the following numbers of votes:

- Governor: Rasa Birutiene, ZC Vilnius 35 votes
- Lt. Governor: Gudrun Halla Gunnarsdottir, ZC Reykjavik 34 votes
- Treasurer: Ellen Skartvedt, ZC Egersund 36 votes
- Treasurer alternate: Thrine Feyling Seglem ZC Egersund 33 votes
- Auditor: Berit Birkelund, ZC Naestved 36 votes
- Auditor alternate: Grete Smistad, ZC Haugesund 33 votes

8. Election of new Nomination Committee

Chair Aase V. Schmidt, Nomination Committee

In D13 the auditor is an elected position and the Bylaws state that a member of the Nominating Committee cannot hold an elected position. This goes for the international as well as district level.

As Berit Birkelund, ZC Naestved is elected as an auditor she cannot be a part of the Nominating Committee. Berit Birkelund therefore withdraw.

It is allowed to vote for the maximum of three (3) candidates. The three (3) candidates receiving the highest number of votes are the elected ones.

There has been given a total of 39 votes, included 1 invalid and 1 blank.

The Candidates for the Nomination Committee obtained the following votes:

- Aurelija Gefeniene, ZC Vilnius 11 votes. Not elected
- Karen Marie Hougaard, ZC Sonderborg 14 votes. *Elected*
- Guðríður Gyða Eyjólfsdóttir, ZC Akureyri 21 votes. *Elected*
- Randi Nygaard Lium, ZC Trondheim 23 votes. *Elected as chair of the committee.*
- Berit Birkelund, ZC Naestved 27 votes. Withdrawn

The above voting was found to be invalid since the delegates did not know of Berit Birkelunds withdrawal at the time of voting and hence would have voted differently. It was unanimously decided that there was no time to find a new 5th candidate. It was decided to send out the 4 remaining candidates for a new voting after the meeting and to publish the result on the district website.

The result of the second and final voting is as follows:

- Aurelija Gefeniene, ZC Vilnius 21 votes. Not elected
- Karen Marie Hougaard, ZC Sonderborg 26 votes. *Elected*
- Guðríður Gyða Eyjólfsdóttir, ZC Akureyri 28 votes. *Elected*
- Randi Nygaard Lium, ZC Trondheim 31 votes. *Elected as chair of the committee*.

There has been given a total of 42 votes, of which 1 invalid vote.

9. Presentation and Approval of the budget and financial statements

D-13 treasurer Ellen Skartvedt presents the financial statement 2019-2021 and the budgets 2020-2023.

Results are characterized by the fact that there has been no travelling because of the Covid-19 Pandemic.



A major part of the cost are provisions that are set aside for the future to ensure enough funds for a high activity after the pandemic.

According to the Auditors endorsement, the Financial Statement and Balance Sheet has been revised and approved.

The Financial Statements and the budgets as presented are approved unanimously, including that the annual district dues are unchanged at 175 DKK for members at least 30 years old, however for members under 30 years of age the dues are only half of this, 87,50 DKK.
