 evaluated several club service projects and forwarded three projects to ZI for recognition at
 the Nice convention. Competition was very hard: however, the project, which was once an
 area 01 project later a ZC Sønderborg project, with the title: Sommer Schools for women in
 Greenland, was recognized as the fifth best of all Zonta Projects in the 2014-16 biennium.

As D 13 Historian and a member of ZI Centennial Anniversary Committee, I will take care of establishing a D 13 E-archive.

The 63 Zonta International Convention at the AKROPOLIS in Nice, France, 30 June – 6 July 2016.

Present at convention were 2323 Zontians and Guests

- International Board 11 persons
- Past International presidents 7
- Governors 31
- Other members registered 1951 +119 on a daily basis
- Guests 204

As of 1 June 2016, Zonta International encompassed 1184 clubs.

- 752 clubs were represented by delegates (From D 13: 34 clubs)
- 335 clubs were represented by proxy (From D 13: 5 clubs. However, members from one of these clubs had decided to attend with no voting rights and Governor could not represent her own club, from which no one else attended)
- 97 clubs were not represented (From D 13: 1 club; however a club member from this club participated with no voting rights)

The convention body recognized **ZI President Maria Jose** for her Conviction, Commitment and Courage and her hard and successful work for ZI. PIP Maria is now walking on as Committee Chair of the ZI Advocacy Committee, and as a member of the ZI Nominating Committee 2016-18.

Sonja Hönig Schouw, ZI President—elect, took office as ZI President 7 July 2016. The other members of ZI Board 2016-2018 are

Tiina Rebane ZC Riga (749 votes) Kerrie Bigsworth (522 votes) and Lalivan Karnchanachari D 17, who was a candidate from the floor (662 votes), were not elected.

Before election, ZI President deleted Georgitta "Beng" Puyat ZC Makati and Environs, D 17, from the list, because her presentation speech did not follow Zonta Rules.

Resolutions (a resolution is only adopted for one biennium; it must be adopted at the next convention to be continued).

There were four resolutions proposed. One was drawn back, one failed and the following two were carried

- 1. The campaign "Zonta Says NO to Violence Against Women" shall be continued in the biennium 2016-2018
- 2. Pilot project "Membership category: Young Professionals"

The latter project caused some discussion, which resulted in a change of the wording **youth membership** into **membership of young professionals**. Those accepted as members in the biennium 2016-18 will continue in this category until they will turn 30 years, even if the category might disappear at the 2018 convention. They will have the same rights and responsibilities as ordinary classified members.

Bylaws

As usual, the Bylaws- day was a long day; however, ZI president managed to keep the estimated time schedule. The Bylaws edition 2016 will be published at www.zonta.org (My Zonta). Please notice that there are changes in the articles concerning ZI Nominating Committee, District Nominating Committee, new articles include the Z- and Golden Z clubs in the Bylaws, and a ZI Leadership Committee.

Please observe that an amendment of Bylaws now allows a former AD to run for election as AD six years after the completion of the area director's first term in that office.

D 13 proposal to make CAC a standing Committee failed as did the proposal of registering for a single day at convention.

ZI president Maria Jose reported on the outcomes of the 2014-16 biennium.

Special attention was drawn to membership with a report from ZI Membership Committee Chair Annette Binder, to finances by Bridget Masters ZI Treasurer/Secretary, to advocacy, UN/CoE as well as to the education programs and the ZI projects.

Keynote speakers were **Maria Luisa de Contes**, Secretary General of the Renault Group in Spain, **Lykke Friis**, University of Copenhagen former Danish minister of environment and gender equality.

The last keynote speaker was **Carolyn Hannan**, former Director for the Advancement of Women, UN New York, currently Associate Professor at the University of Lund teaching master-level courses in gender equality and development. Dr. Hannan is a ZI Honorary Member.

There were also speeches by Camille Bilger, 2015 AE Fellow, Anna Rukko, 2015 YWPA Recipient and Jelena Bauer, 2014 Jane M. Klausman Women in Business Scholarship Recipient.

ZI President 2016-18 Sonja Hönig Schouw presented the biennium goals

- Service. Zonta's service programs reflect and enhance our mission and focus on sustainability
 - a. Sustainability is ensured through involvement of local and national governments and NGOs
 - b. Local (district/club) projects are in-line with our mission and vision, 100% of clubs have all local projects focus on women's and girls' issues. Cooperative projects will only be undertaken with like-minded organizations
 - c. ZI identifies and proposes one major Zonta-led project with the potential to become a long-term on-going project. The new major project will be presented at the Convention 2018. (I want to draw your attention to the fact that ZC Sønderborg made a similar proposal at the D 13 conference in 2011 in Akureyri. Time was not ready for the proposal, which was not adopted)
- 2. **Advocacy.** Zonta International is a leading advocate for women's rights
 - a. All advocacy actions are in-line with the strategic plan and have measurable impact. When relevant, cooperation with like-minded organizations is initiated.
 - b. The campaign to End Violence Against Women is further developed to achieve local and national governmental and community commitment
 - c. ZI, districts and clubs report actions in support of the Women's Empowerment Principles (please see below)
- 3. Membership. Zonta International builds and sustains a vibrant global membership
 - a. Zonta engages the next generation of gender equality advocates
 - Clubs recruit and retain committed and skilled members. Districts show a net membership growth of at least five percent compared to the previous biennium and at least one additional club during 2016-18 biennium
- 4. Resources. Zonta International maintains resources to support mission and vision fulfillment
 - a. Leadership training and membership knowledge is reinforced
 - b. The communication and knowledge management platforms are improved
 - c. ZI has sustainable resources and the sources of income are broadened

- 5. **Centennial Anniversary**. Zonta's Centennial anniversary celebrations have visibility around the world.
 - a. ZI delivers the strategy and plans for the Centennial celebrations to the governors by the first quarter of 2017
 - b. Districts establish an Ad Hoc Committee for Zonta's Centennial Anniversary for coordination of events

 - The Future We Want: Creating Sustainable Foundations for Addressing Human Trafficking and Unsafe Migration of Women and Children in Nepal. With UN Women: 1,000,000 USD
- 3. Education Programs
 - a. Amelia Earhart Fellowships 700,000 USD
 - b. Jane M. Klausman Women in Business Scholarships 232,000 USD
 - c. Young Women in Public Affairs Awards 144,000 USD
- 4. Rose Fund
 - a. Rose Fund 300,000 USD

Total Amount 5,376,000 USD

- The Galla Dinner, mistress of ceremonies Tebbie Clift ZC New York.
- Happy Hour for District 13, chaired by D 13 Governor assisted by District Treasurer and the
 ADs 2014-16 for practical things and Helena Bjarnadóttir for the songs and the singing. Very
 many D 13 Zontians and guests participated in this event. However because of a tight
 schedule we missed Maria Jose and Ingibjörg Eliasdóttir; nevertheless, there was a toast to
 Maria Jose for work well done and good wishes for the incoming governor.
