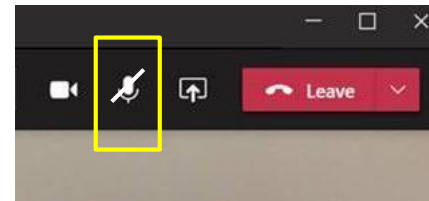

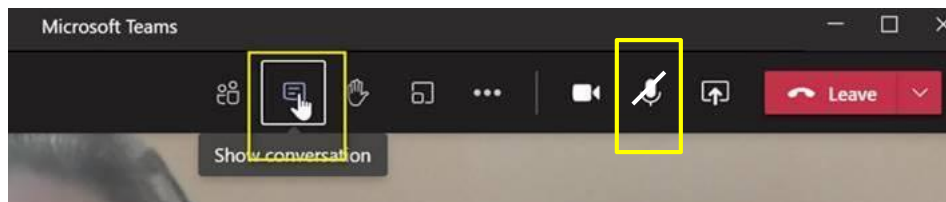

What Is the United Nations?

International organization founded in 1945 after the Second World War by 51 countries.

Comprised currently of 193 Member States committed to

- maintaining international peace and security,
- developing friendly relations among nations
- promoting social progress, better living standards and human rights



Main organs of the United Nations?

Established already in 1945

- General Assembly – RECOMMENDS
 - 193 members, 1 country = 1vote
- Security Council – DECIDES, responsible for peacekeeping forces
 - 5 permanent members (allies in and victors of World War II): China, France, Russia, the United Kingdom, and the United States. Each one of this countries has the power of veto.
 - 10 other members elected for 2 year terms: Norway since 2021
- UN Secretariat - IMPLEMENTS
- Economic and Social Council (ECOSOC)
- Trusteeship Council
- International Court of Justice

The Secretary General

Symbol of the Organization's ideals and a spokesman for the interests of the world's peoples, in particular the poor and vulnerable.

The current Secretary-General of the UN, and the ninth occupant of the post, is Mr. António Guterres of Portugal, who took office on 1 January 2017.

 - merging of UNIFEM, the International Research and Training Institute for the Advancement of **Women** (INSTRAW), Office of the Special Adviser on Gender Issues (OSAGI), and Division for the Advancement of **Women** (DAW)
- 25th Anniversary of the Beijing Platform for Action (**Beijing +25**)
- 5th Anniversary of the 2030 Agenda (SDGs)
- 20th Anniversary of the Security Council Resolution 1325 on Women, Peace and Security
- 20th Anniversary on the Convention on the Rights of the Child

Helvi Sipilä, Zonta Past International President (1968-1970), was the first woman appointed Assistant Secretary-General of UN (1972), at a time where 97% of UN senior management was male.

She headed the Centre for Social Development and Humanitarian Affairs until 1980 and used her leadership position in the UN effectively to advocate for gender equality and the empowerment of women.

She also served as Secretary-General for the First World Conference on Women held in Mexico City in 1975.

The UN and Women

- 4 World Conferences on Women
 - Mexico City in 1975, Copenhagen in 1980, Nairobi in 1985 and Beijing in 1995
 - Beijing Platform For Action (B +25 +1)
- UN Women
- Commission on the Status of Women (CSW). Met first time February 1947. CSW65 Forum (2021) to be virtual and free of cost for all.
- Convention on the Elimination of All Forms of Discrimination against Women (CEDAW). Entered into force on 3 September 1981



The UN and Women

- Declaration on the Elimination of Violence Against Women (DEVAW). 20 December 1993
- Security Council Resolution 1325 on women and peace and security, 31 October 2000.
- ILO Convention 190 Eliminating Violence and Harassment in the World of Work, 2019
- Convention on the Rights of the Child, 2nd September 1990
